In Court - Events



Jour d'Honneur

Anyone who attended Jour d'Honneur will agree that it was a beautiful event. It had the best of SCA on display.

For those helping with set up, the day started early. With people at both the tournament field and the feasting hall, things were quickly set up. By the time the first fighters took the field, Valley Reserve and Mt Waverley Community centre were much transformed from the modern world. Colour and pageantry were everywhere.

The event opened with the final round of the Winter Rapier Tournament Series.

The tournament style was based on a very elegant style. It was fought for points, not to injure. Following this, a person had to hit their opponent twice to win a round. A fighter who was hit did not lose an arm or a leg. They simply counted the two good shots out loud. Once they won the round the winner got 3% of the loser's points.

In addition to this, the crowd were each given 3 honour points to award to whichever fighter they thought the most honourable on the field. It was a most enjoyable tournament to watch.

In the end it was Everard who won the final round of the Series. However, it was Leif who was the overall champion, with his points in honour.

Next the heavies took the field, using the same format and points system. The number of new fighters on the field was quite impressive. It was highly enjoyable to watch as the fighters had to go against their training and not go to their knees when being legged.

The very first heavy tournament of Jour d'Honneur was won by Hrothgar Aet Gytingbroc. The best thing about this tournament format, is the score will carry over to next year's Baronial event. New people will start with 1500, as did the fighters who started with this year.

Once the fighting was finished, we re-located to the Feasting hall, which was decorated with beautiful tapestries and banners. There were a few changes, and people's best court garb came out for the occasion.

The French themed meal was divine, with many platters being emptied throughout the night. Some of the food featured was lamb, chicken and especially the hare. The vegetables included stuffed mushrooms, and leek, which were very tasty. The pears poached in wine, and tarts with blue octopuses as decorations all went very quickly. The soteltie was an amazing jelly octopus surrounded by fruits and a tart on top of the Krae Glas device. The food, and the mulled pear juice were easily worth the months of waiting.

During court, many awards were given out. Congratulations to the following people for their Baronial awards. Bethony Gaitskell received the Baronial Spurtle. Dmitri Rozenov, Simon of Krae Glas and Louisa of Krae Glas all

received the Baronial Endorsement. Everard Sefar received the Martial component of Apollo Dolphinus. Aylwin Greymane and Ingerith Ryzka both received the Etruscan Dolphin. Finally, Gwir verch Madog was the first in the Barony to receive a dual Apollo Dolphinus, for both her Service to the Barony and her contribution to A&S. Congratulations to all of you!

Apart from these awards Bethony became the Protégée to Gwir. Congratulations to both of you.

So what was the best on display, you may ask? Well, the answer is everything. Starting with the volunteers helping with the day, The final of the Rapier series, The shiny heavy fighters that were both old and new, The beautiful decorations, the stunning garb, the A&S entries and of course that absolutely wonderful food that was served. Winter Rapier Tournament Series – Final Round

It was a clear, cool day for the final round of series. The final tournament was based on a very elegant style. Where each fighter started with 1500 points and if they won they were awarded 3% of their opponent's points. This means that in the first round both fighters had 1500 points. At the end of the round the winner had 1545 and the loser had 1455 points, pushing them lower on the board. However in round 2 the winner of the previous round had more points. If they were beaten the new winner walked away with 46 of their points.

The tournament was fought for points, not to injure. A rapier hand who was hit did not lose an arm or a leg, they just counted out loud the number of good touches. A person had to hit their opponent twice to win a round.

A death blow was allowed, which meant one strike after getting hit twice. This could result in a draw and no points being divided.

In addition to this, the crowd were each given 3 honour points to award to whichever fighter they thought the most honourable on the field.

It was a most enjoyable tournament to watch. The fighters were very courteous and obviously having fun with the new format. The crowd having points to give, had more reason to discuss the fighting than usual.

In the end it was Don Everard Sefar who won this round of the series.

The entire series ended in a draw between Leif Magnusson and Jarek Blackthorne. However, taking into account the honour points awarded in the final round, Leif managed to break the tie and claim the rank of Captain of the City Watch. Quite appropriate that our new Captain would start the next year with honour as his best weapon.

An Account



The Day of Honour - An account

Their Excellencies Baroness Elspeth Caerwent and Baron Cormac Lenihan were feeling in a festive spirit and decided the Barony of Krae Glas required a grand day to celebrate the riches of talent in their populace. Lord Gib for Hire was charged with creating a day of celebrations that would remain memorable in the hearts of those that attended the day and leave them looking forward to the next Day of Honour.

Lord Gib promptly assembled a team together and shared their Excellencies wishes. The team was instructed to create a day that would test the mettle of the Barony's Artisans and the martial prowess of both its civilian and military members. Their Excellencies also wished for the tournaments to be unique, to ensure its participants skill of hand and quickness of mind would be tested and judged worthy by the populace at large. Honour was to be the currency of the day.

The team struggled with a name for the day that would capture the spirit of Their Excellencies wishes. One team member was reading *La Scherma* (The Art of Fencing), first published in 1640 by Master of Arms, Francesco Ferdinando Alfeiri. Alfeiri studied all the great Sword Masters before him which inspired him to write: "Of all the forms which iron takes, the sword is the most noble. It is used by every sort of person, both by civilians and by soldiers, the former to defend honour, the latter to acquire it.

The ideal of honour is deeply engrained into the fabric of the Society and as such was deemed fitting in spirit and name for the celebration. Their Excellencies declared the day would be known as the "The Day of Honour" and would feature both a rapier tournament named "Defending Honour" and an armoured tournament named "The Gathering of Honour" and the grand feast that followed, "Feast of Honour".

As it was the wishes of Their Excellencies to celebrate with a French flavour, the inaugural celebration was called "Jour D'honneur (Day of Honour)" the rapier tournament "la défense de l'honneur (Defending Honour)", the armoured tournament "l'assemblage d'honneur (Gathering Honour)" and the grand feast "Célébration d'honneur".

The team's next challenge was to structure a tournament that met Their Excellencies wishes. As honour was the currency of the day, it was decided the combatant that displayed the greatest honour as deemed by the populace would be declared the winner of the tournament. All non combatants/spectators would be given 3 Honour tokens that would be awarded to the combatant who in their opinion displayed the ideal; honour displayed through skill of hand and their chivalrous actions on the field. As Her Excellency has great riches of honour she was feeling generous and announced she would award such wealth as she saw fit.

So the populace had the means of sourcing the champion of the day, yet we still required the means of ranking the combatants. An ingenious system was created involving the combatants exchanging a portion (3%) of their points of honour at the conclusion of each bout. Every

combatant commenced the tournament with 1500 points of honour and would seek challenges over a set time period. As individual bouts were decided, the honour points would be exchanged and at the conclusion of the tournament the List Officer was able to rank the combatants. It's yet to be decided if a combatant's value will be carried forward to future tournaments.

The team now had a means of ranking the combatants but required a means of testing the individual bouts that would please Their Excellencies. Again Francesca Ferdinando Alfieri directs us to a solution. He writes of the danger of not observing measure after wounding your opponent if you fail to retreat (death blow).

"Having observed the tempo and the measure you should be able to wound them and save yourself by retreating with two steps, quickly returning to your enemy's sword to secure yourself against any effort he might make in a condition."

This led the team to a Manuscript known as Anonimo Bolognese (Biblioteca Classense di Ravenna MS345 and 346) dating from the early 16th Century. The manuscript describes how the contemporary rules of recreational swordplay with blunt weapons permitted a combatant that had been struck, one step in which to return the blow to his opponent. This practice was founded in observation of real combat where it was seen that the first blow may not have been lethal. MS345 Paragraph 12 speaks of an opponent who wishes to throw himself upon the enemy to take revenge after receiving a blow but often the nature of the blow limited movement hence one step was used.

While we were not able to gain a complete understanding of the 16C recreational swordplay rule, secondary sources suggest the following:- a point systems was employed involving allocating different values to different parts of the body.

- hands were not a target,
- a death blow (one set/blow) was allowed.
- blows to the limbs didn't result in the lose of usage of the limb.
- If you lifted your opponent off the ground you won.

After taking the SCA rules into account and to ensure the structure was simple, it was decided the rapier tournament would be a counted blow of any 2 legal target areas excluding the hands and a death blow was allowed, which often resulted in a draw. Blade grasping was not allowed. The armoured tournament used a slightly different system being that a single blow to the head or body would result in a win or two legal blows to a limb would result in a win. For example a blow to a leg and then an arm would be counted as two/win. The death blow also featured and proved to be popular with the combatants and spectators alike.

I hope the above proves to be a useful record of the name and structure of the tournament now known as "The Day of Honour".

Testing of Fencing Armour

If your hood and/or body armour has not been tested within the last 2 yrs you have until the 31st October 2013 to get it done. After this date you will not be able to use the equipment until it's tested and found to be acceptable for SCA rapier combat. The practice of accepting any 4 layers of fabric as puncture resistant without testing is not acceptable and must stop. If you are currently wearing 4 layers and it has not been tested within the last 2 years you are also required to have it tested by the 31st October 2013.

Recipes

Mini Moot Recipe Series - Part 3

Anyone who was at Mini Moot this year, will agree how wonderful Saturday night's feast was. Lady Isobel Rosewell provided a truly delightful culinary experience.

Well, now she has provided the actual recipes that were used, for all to enjoy. In this special series all the recipes will be printed. This is part 1 of the Mini Moot Recipe series.

The original recipes were from "The Good Huswives Handmaide for the Kitchen: A Period Recipe Book" published around 1590, and again in 1992 by Stuart Press."

The redactions are by the good Lady Isobel, herself. We hope you enjoy them.

Leavened bread

Recipe

take six yolks of eggs and a little peece of butter as big as a walnut, one handful of verie fine flour and make all these in paste and all to beat it in a rolling pin till it be as thin as a paper leaf, then take sweet butter and melt it and rub over all your paste therewith with a feather: then roll up your paste softly as ye woul droll up a scroll of paper then cut them in peeces of three inches long, and make them flat with your hands oand lay them on a sheet of clean paper and bake them in an overn or pan. but hte oven may not be too haot and they most bake half an hour. then take some sweet butter and melt it and put that into your paste when it comes out of the oven and when they are verie wet so that they be not drie take them out of your utter and lay them in a fair dish and cast upon them a little sugar and if you please cinnamon and ginger and serve them forth.

Redaction

6 egg yolks, 1 tbsp butter (softened) and 1 cup of white plain flour. Mix well, then feed through the pasta machine. When it is as thin as the machine can make it, spread liberally with melted butter, and sprinkle with Cinnamon-sugar mix. cut into 15cmlong strips. Roll up loosely. and place on baking paper on a tray. Bake in a 180 oven approx 30 mins. pour melted butter over the scrolls, sprinkle with more cinnamon sugar, and when they have soaked up sufficient butter, transfer them to a serving tray.

Apple Moy

Recipe

take apples and cut them in two or four peeces boyle them till they be soft and bruise them in a mortar and put thereto the yolkes of two eggs and a little sweet butter. Set them on a chafingdish of coals and boyle them a little and put thereto a little sugar, cinnamon and ginger and so serve them in.

Redaction

Peel/core/slice apples, boil them in a tiny bit of water, until very tender. Mash apples, mix with egg yolks and a little butter. Simmer slightly, season with sugar cinnamon and ginger.
